

Terms and conditions of use

These terms and conditions of use apply to all use of the XefoCoin website and all trading on the Xefocoin website. By registering on the Xefocoin website or by trading on the XefoCoin website you are agreeing to enter a legally enforceable agreement with Xefo Trading LLC on the basis of these Terms. If you do not agree to these Terms you must not register on this website or trade on it. Our privacy policy also forms a part of these Terms.

Introduction

The XefoCoin website and the Xefocoin apps are tools owned, maintained and operated by Xefo Trading LLC, that allows individuals registered on this website to trade, invest or use as payment xefocoins worldwide. These terms of service form the agreement under which users can receive the XefoCoin services and access the XefoCoin website (together referred to as the “Website”). XefoCoin enables Users to:

- Exchange Xefocoins for other currencies
- traditional currencies for Xefocoins
- invest Xefocoins
- pay using Xefocoins as valule

All trades are made between the Users. Therefore the website enables currency trade by enabling a User to trade currency from another User.

Xefocoins

Xefocoins may not be appropriate for everyone. Before using of XefoCoin you should learn about it to ensure it is appropriate for you. As with all currencies, there are some risks associated with using xefocoins. Some of the risks particular to xefocoins include:

- loss of xefocoins due to user error or hardware malfunction;
- currency fluctuation – the price of xefocoins may fall sharply and may even fall to zero;
- xefocoins transactions may be unconfirmed for a period of time. Although very unlikely, some xefocoin transactions may never be confirmed – xefocoins transactions which are unconfirmed may not be completed;
- xefocoins transactions are irreversible – if you send xefocoins to the wrong person, you may be unable to recover that cryptocurrency;
- xefocoins may be lost if you lose or forget any PINs or passwords necessary to access and spend those xefocoins;
- technical defects inherent in cryptocurrency protocols which are unknown;
- new regulation which impacts on cryptocurrency use.

Requirements

By using this site, the user declares and guarantees that all information provided here is true and accurate, and he or she is of legal age, respectively in case of underage persons they have the consent of the parents or the legal representatives and that his use of the website does not infringe applicable laws of the local legislation. XefoCoin may refuse access or block access to the website without prior notice in case the requirements specified above are not fulfilled .

XefoCoin reserves the right to seek, using all legal means, protection and compensation for committed or alleged violations, including, but not limited to, the right to block access from an IP address to the website, while this does not waive the responsibility and free the user from the obligation to pay for all potential damages.
